APPLICATION DUE DATE

The Artist's Application MUST be post marked no later than June 10, 2012. Notification will be given on or before July 1, 2012.

FEES

A non-refundable application fee of \$25 is required. The booth fee is \$125 for a 10' x 10' booth space. Artists must provide their own booth with **white** canopy. These fees must accompany your application. Booth fees from artists not accepted will be returned. Prior to July 30, 2012 booth fees may be refunded IF your space can be filled from the approved waiting list. Checks post-dated or returned unpaid by the bank will result in immediate disqualification. No rain date.

JURY PROCESS

Please submit three images of your artwork and one of your booth fully merchandised. Please submit original current art only. Images should include name and price on each image. Images can be mailed via USPS with application or via email. Please include your name in the subject line and e-mail to: (Gretchen@BrookhavenArtsAlliance.org) If accepted, exhibitors must show and sell work of the same type and style demonstrated through the application process. Artists may not sublease assigned booths or employ sales agents in lieu of attending festival. Include a self-addressed, stamped envelope for return of your booth fee if you are not accepted. Photos and CD's will not be returned. Artists sharing booth space is not encouraged. No generators are allowed.

JUDGING AND PRIZES

In 2007 a new category called Commemorative Poster Winner was created. The 2-D artist will be awarded the honor of representing the Brookhaven Arts Festival on its t-shirts and posters for 2013. The winner will also be guaranteed entry plus corner booth placement at the 2013 event. The winner can be awarded by an independent judge(s) or by a Brookhaven Arts Alliance committee.

Prizes for First, Second and Third place will also be awarded. All mediums are eligible. The First Prize recipient will receive guaranteed entry and booth fee waived. Second place recipient will receive guaranteed entry and 50% booth fee waived for the 2013 Brookhaven Arts Festival. Third place recipient will receive guaranteed entry and a 25% discount on booth fee for the 2013 Brookhaven Arts Festival. Judging for prizes will begin at 10AM Saturday, October 20, 2012.

SALES TAX

Each exhibitor is responsible for collecting and remitting the 7% Georgia sales tax (DeKalb County).

SECURITY

Exhibitors are responsible for their own personal and property liability. Please leave pets at home. Brookhaven Arts Alliance will provide over night security and carries event and liability insurance.

Set-up time begins at 6:30 AM on Saturday, October 20th. Maps and parking information will be sent after acceptance to the Brookhaven Arts Festival is confirmed.
